Introduction

This finding aid describes a collection of publications, legal papers, legislation and other printed materials relating to the 1925 Church Union. The records are mainly examples of material produced by the various committees on union of the Presbyterian Church in Canada, 1907-1925, along with publications supporting the union with the Methodist, Congregational and Local Union Churches which resulted in the formation of the United Church of Canada on June 10th 1925. It is likely that these documents were first collected by Austin L. Budge as convener of the Historical Committee, and that the original collection was added to by small deposits, possibly including deposits after 1973. The collection was given a preliminary listing around 1977. During the re-cataloguing material issued by the Presbyterian Church Association was transferred to that collection (Accession #1982-1003).

Related records can be found at the United Church Archives and in the records of the Board of Administration (Accession #1973-1007), the Presbyterian Church Association (Accessions #1973-1003 & 1982-1003) and in records of congregations, presbyteries and synods. ~~There are also scrapbooks, re-mounted and indexed by Gordon Allison in 1989, which are held in the Reference Collection of the Presbyterian Archives.~~

Historical Sketch

The movement towards church union which resulted in the formation of the United Church of Canada in 1925 began in 1902 when three delegates of the General Assembly to the General Council of the Methodist Church issued an invitation to the Methodists to consider church union. The impetus for union came mainly from western Canada where the churches felt that they were competing with each other unnecessarily. A joint committee on church union was appointed with representatives from the Methodist and Presbyterian Churches and later representatives from the Congregational Church and the Local Union Churches also participated. Opposition towards union was organized through the Presbyterian Church Association in the Presbyterian Church: there was little organized opposition in any of the other Churches. The union was consummated on June 10th 1925 but about a third of the Presbyterian Church declined to enter the union.

Scope and Contents Note

This collection of material relating to the 1925 Church Union is an artificial collection comprising approximately 0.5 metre of pamphlets, legal papers and other printed papers. The material is grouped in files which are listed under the name of the committee which produced it: the correct names of the various union committees have been used. Pamphlets are listed in alphabetical order of title within each file. The files of union committees are listed in approximate chronological order and are followed by anonymously published pamphlets. The legal papers and copies of legislation are listed after the Committee files along with three files relating to the union proceedings in 1925. *The collection includes three scrapbooks, re-mounted and indexed by Gordon Allison in 1989.*
