**Board of Congregational Life fonds. - 1972-1992. - 15 m. of textual records.**

The Board of Congregational Life was established by the 98th General Assembly in June of 1972 as an agency for the support and encouragement of congregational life and mission within The Presbyterian Church in Canada. A pro\*tem Board was appointed in June of 1972 to serve until the 1974 General Assembly. Programming began on January 1st, 1974, and continued until the Board was dissolved by the action of the 118th General Assembly in June of 1992.

The principal functions of the Board of Congregational Life were to provide congregations with: 1) support and motivation; 2) leadership and resources development; and 3) research and planning. The BCL brought together under one mandate many of the functions of three former agencies: the Board of Christian Education, the Board of Evangelism and Social Action, and the Board of Stewardship and Budget (all three were dissolved by General Assembly on December 31st, 1973).

In 1974 the BCL's administrative structure was composed of: a Board, an executive committee of the Board, standing committees on leadership development and resource development, numerous advisory committees on various aspects of programming, task forces, and structural relationships with the W.M.S. (W.D.), the Board of World Mission, the National Committee of Presbyterian Men and the National Advisory Council for Youth Ministry. Although the Board underwent various changes in organization during its existence, major restructuring took place in 1979, 1982, and 1986.

In March of 1982 the BCL was restructured into five principal functions (each with a standing committee), the priorities being adult education, ministry with laity, and support for worship. The last major reorganization of the agency occurred in 1986, with the following areas of responsibility established: Church and Society, Church Education, Worship, Evangelism, Stewardship and Camping and Outdoor Ministries. In 1988 Research and Church Growth became part of the BCL agency, with a mandate to operate until December of 1990.

As part of the national body of The Presbyterian Church in Canada, the BCL often worked in conjunction with other agencies of the Church. Collaborative efforts resulted in the Joint Task Force on Mission Education, the Joint Task Force on Field Services, the Consultation on Church and Society, and the Joint Task Force on Church Growth, as well as other special projects.

The Board of Congregational Life was administered by a General Secretary. Associate Secretaries were assigned a specific area of responsibility within the major programmes of the BCL. Support and field staff (Area Education Consultants) were also part of the staffing structure of the BCL. The use of field staff was a policy begun by the Board of Christian Education, with consultants deployed to all Synod regions of the Church. Employed by the W.M.S.(W.D.), they were appointed jointly by the W.M.S.(W.D.) and the BCL, and represented both agencies out in the field. When the BCL was restructured in 1986 the title of General Secretary was changed to Executive Director, while Associate Secretaries became known as Programme Directors. Although the Board set out policy objectives and goals, the work of the BCL was directed throughout the year by committees. Committees were appointed by, reported to, and were accountable to the Board. Throughout the BCL's existence, its committees were appointed by the Board in each area of responsibility of the Board's work. Executive staff were assigned a primary area of responsibility within the Board's functions. Executive staff were also accountable to the Board, rather than directly to the committees themselves, although the lines of authority were not always obvious.

For a more complete administrative history please refer to the section on Principles of Operation of the Policy Manual of the Board of Congregational Life.

Records of the Board of Congregational Life were transferred from the national office of The Presbyterian Church in Canada to the Archives in two successive transfers, 1989 and 1992.

The records of the Board of Congregational Life document the educational role in leadership training and resource development that the agency provided to Presbyterian congregations from the mid-1970's to the early 1990's. Multimedia records, including photographs, slides, and audio-visual material, have been removed from the collection for processing at a later date. Fonds includes the following sousfonds: records of the Board, records of the office of the Executive Director, records of the BCL Programme Areas, and Resources and Publications.

*Board of Congregational Life fonds*

The records of the Board include minutes of the committees and task forces which set the mandate, policy and organizational structure for the operation of the BCL. The records of the office of the Executive Director record the administrative and personnel history of the operation of the Board of Congregational Life as a whole. The various programmes of the BCL reflect the subject nature of the records in this fonds: worship, evangelism, stewardship, camping, social and economic justice issues, church education and church growth. Types of textual material in the collection include administrative records, correspondence, reports, minutes, personnel files, resources, and periodicals. Minutes of committees and task forces scattered throughout the collection were placed in one series within the Board sousfonds. Publications which were scattered throughout the fonds have been artificially grouped into one series.

Several files contain records predating the existence of the BCL, since many functions of the Board of Congregational Life were continuations of programmes begun by former agencies of the Church. Several of the national staff who had been employed by the Boards which were dissolved in December of 1993 and transferred to the new Board of Congregational Life in 1974. There is a gap in the records from the Stewardship programme, allocations for the years 1975 to 1991 are missing, as well as records relating to Presbyterian Sharing. There is very little material for This Mission is Ours. With regard to education, there is limited material on curriculum development predating 1986.

Records originating from a joint committee or from a General Assembly committee have been removed from the Board of Congregational Life fonds. This includes records of the: Consultation on Church and Society, Subcommittee on the Covenant of Grace of the Church Doctrine Committee, Children at the Lord's Table, Special Committee re Church in the World, Joint Task Force on Church Growth, the Special Committee re Liberty of Conscience, Committee on Church Growth to Double in the 80's, and Special Committee re Church in the World.

**Notes on Using Finding Aid**

Consult the series descriptions for a summary scope and content note for that level of description. Appendices to the individual series contain the file list for each series.

The series descriptions indicate the existence of confidential or restricted files, although such records are minimal. Please confer with the Archivist regarding use of these and other potentially restricted materials.

Researchers should note that after the national church organization was restructured in June of 1992, many of the functions of the now defunct BCL continued as part of the Life and Mission Agency, particularly the ministries of Education for Discipleship and the Social Justice Ministries.

**Records of the Board sousfonds. - 1972-1992. - 1.5 m. of textual records.**

The Board of Congregational Life sousfonds documents the mandate, functions, and policy decisions of the overall agency. The Board met twice each year, at which time it set goals and objectives for the various programmes of the BCL. It established purpose statements, and reviewed the work of the various committees and programme areas.

The Board appointed committees for each area of responsibility of the Board's work. Executive staff reported to the Board as they were the ones responsible for achieving the policy objectives set out by the Board. For more information on the structure of the BCL, please consult the administrative history in this finding aid.

This sousfonds consists of the following series: Administrative records, 1973-1991; Annual and Semi-Annual Meetings, 1973-1992; Executive Committee, 1973-1992; and Committees and Task Forces, 1973-1992.

**Administrative records of the Board. - 1973-1991. - 12.5 cm. of textual records.**

Administrative records contain files of the Committee on an Agency for Congregational Life, which became the Executive of the Board of Congregational Life. These files consist of draft plans of the organizational structure of the BCL, reports from the various programmes and boards which were integrated into the new Board of Congregational Life, guidelines, correspondence and purpose statements. This series also contains policy statements and correspondence.

**Records of the Executive Committee of the Board. - 1973-1992. - 37.5 cm. of textual records.**

The Executive Committee of the Board met throughout the year. Records in this series consists of minutes, appendices, and reports to the executive.

**Records of Annual and Semi-Annual Meetings of the Board. - 1973-1992. - 37.5 cm. of textual records.**

The Board usually met twice, in November and March of each year. Reports to the Board contain much information on all of the work carried out by the agency, as well as information on structural relationships with other bodies, both within the national structure of the church and outside of it. The annual and semi-annual reports to the Board are the most complete source of information on the overall operation of this agency. Minutes of the meetings are also part of this series.

**Records of the Committees and Task Forces of the Board. - 1973-1992. - 1 m. of textual records.**

The committees and task forces of the Board of Congregational Life document the changes in mandate and policy of the various functions of the BCL. This series consists of minutes and appendices, arranged in alphabetical order according to the name of the committee or task force. Researchers should note that minutes of the Task Force on Church Camping, minutes of the National Church Camp Subcommittee, and minutes of the Subcommittee on Church Camping have all been placed in the file entitled Committee on Church Camping (1992-1260-4-5). For minutes of the Task Force on Field Services, please see the Task Force on Delivery of Services. For information on the Stewardship Advisory Committee, please see the Advisory Committee on Stewardship. Minutes of the Subcommittee on Community Concerns have been placed in the file entitled Task Force on Community Concerns. The minutes of Staff Meetings are distinct from the minutes of the Staffing Committee, the former being minutes of the executive and support staff, while the latter is a committee comprised of Board members. The Staffing Committee contains material of a confidential nature. Please consult with Archivist regarding access to restricted material.

**Records of the office of the Executive Director. - 3.2 m. of textual records.**

It is within the sousfonds of the office of the Executive Director that the major administrative and staffing decisions of the BCL are documented. As the Executive Director was responsible to the Board for the implementation of Board policy goals and objectives, the Executive Director had a significant role in the everyday running and operation of the Board of Congregational Life. Responsibilities of the Executive Director included: communicating with congregations and church courts regarding leadership training and selection and use of appropriate resources, providing leadership of the executive and administrative staff, general administration of Board committees and task forces, representing the Board on other boards and committees of the Church, administering the Board's budget, participating in Presbytery and congregational field work by conducting leadership training workshops. The Executive Director represented the BCL on the following committees: the W.M.S. (W.D.) Personnel Task Force, the Executive of the Board of World Mission, W.M.S. (W.D.) Education Committee, the Committee on Church Growth to Double in the 80's, and other special committees appointed by General Assembly. Leadership development records are located with the records relating to Church Education. For further information please consult series description. Throughout the existence of the BCL there were four executive directors: The Rev. Wilbert L. Young (1974-September of 1983); The Rev. Harry Waite (1983-March 31st, 1988); The Rev. Dr. Alex S. MacDonald (Interim Director, April 1, 1988-June 1989); and The Rev. L.E. Siverns (August 1, 1989-December 31st, 1991). Sousfonds consists of BCL Committees and Task Forces, 1974-1987; Administrative records, 1974-1991; Synod records, 1973-1992; Staffing and personnel records, 1974-1989; and records of the Area Educational Consultants, 1974-1987.

**Records of the BCL Committees and Task Forces of the office of the Executive Director. - 1974-1987. - 62.5 cm. of textual records.**

One of the responsibilities of the Executive Director was to administrate and co-ordinate the various committees and task forces of the BCL. Thus this sousfonds contains a series of reports and correspondence relating to the various committees and task forces. Files are arranged alphabetically by name of the committee of task force. The file on Task Force on Staffing Needs contains records of a confidential nature.

**Administrative records of the office of the Executive Director. - 1974-1991. - 1.1 m. of textual records.**

Administrative records are arranged in alphabetical order by subject file title. Series consists of financial records, correspondence, reports, position papers, notes, statements, information sheets, form letters to Presbytery Convenors and Presbytery Clerks. Financial records dealing with budgets are also located in this series. Several stewardship files can also be found with the administrative records. The file on Presbyterian Publications contains correspondence and notes regarding distribution of BCL resources and curriculum.

**Staffing and personnel records of the office of the Executive Director. - 1974-1989. - 25 cm. of textual records.**

The series on staffing and personnel consists of correspondence, performance reviews, resumes, exit interviews, job descriptions, and details concerning nominations for the various executive positions of BCL staff. This series contains restricted records. Please consult with Archivist regarding access to restricted material.

**Synod records of the office of the Executive Director. - 1973-1992. - 75 cm. of textual material.**

Synod records consist of correspondence with congregations, presbyteries and individuals, arranged according to a geographical area (ie. synod). Correspondence generally relates to BCL resources, programmes and workshops. This series also contains files on synod grants and synod consultations, the latter consisting of drafts, goals, evaluations, correspondence, and completed evaluations that relate to church growth.

**Records of the Area Educational Consultants of the office of the Executive Director. - 1974-1987. - 37.5 cm. of textual records.**

Records of the Area Educational Consultants consists mainly of monthly reports, detailing the type of work and comments on field work. Correspondence with the consultants and the clerks of presbyteries are also part of this series, as well as correspondence between the consultants and Helen Tetley, Programme Director, regarding materials, training events, and resources. As the Area Educational Consultants were employed by the W.M.S. (W.D.), the BCL Executive Director also sat on the W.M.S. Education Committee and the Personnel Task Force. Files have been maintained in their original order. This series contains performance reviews, which are confidential. Please consult with Archivist regarding access to restricted material.

**Records of the BCL Programmes sousfonds. - 1972-1992. - 8.6 m. of textual records.**

The work of the Board of Congregational Life was divided into areas of responsibility. Sousfonds consists of the following series: Camping, 1974-1992; Church Education, 1973-1992; Church and Society, 1984-1992; Evangelism, 1979-1991 (predominant 1986-1991); Evangelism Programs and Community Concerns, 1972-1985; Research and Church Growth, 1988-1990; Stewardship, 1974-1986; and Worship, 1974-1992.

**Records of the Camping Programme. - 1974-1992. - 1.4 m. of textual records.**

From 1974 to 1979, the Advisory Committee on Church Camping was responsible for policy regarding church camps. As of 1979, church camping was sponsored directly by synod and presbytery committees. The BCL continued to have responsibility for recommending resources and assisting with leadership training events.

In 1980, the BCL received a capitol bequest, the Gladys E. Montgomery (GEM) Fund. At this time, the Administrative Council asked the BCL to develop a proposal for the use of this fund. GEM money was to be used for leadership development through the Camping and Outdoor Ministries (COM) Committee, then after 5 years the money would be used as capitol assigned to individual camp initiatives. For a history of the Gladys E. Montgomery Fund, please see the 1985 Acts and Proceedings.

Series consists of Administrative records of Church Camping, 1974-1985; Administrative records of Camping and Outdoor Ministries, 1982-1992 (predominant 1986-1991); Synod camp records, 1974-1991 (predominant 1986-1991); and Leadership development records, 1986-1991.

Administrative records for church camping consists primarily of correspondence and reports from camp directors. The majority of records in this series belongs to Brant Loper, who was the staff person responsible for camping from 1974 to 1984. There is very little material for 1985, camping correspondence from 1985 originates from the General Secretary.

Administrative records from Camping and Outdoor Ministries originate primarily from Shirley Ford, Programme Director. The majority of records date from 1986 to 1991. A few records date from 1992, when responsibility for camping was under the direction of Ian Clark. Included in this series are correspondence, reports, proposals, applications, and records relating to COM volunteers. Earlier records in this series are reports, questionnaire results, budgets, background papers, legal documents, and all other records relating to the Gladys E. Montgomery Estate. GEM files contain notes from the transition team responsible for the formation of the Committee on Camping and Outdoor Ministries.

Synod camp files include applications for GEM fund, reports, director's reports, annual reports, planning sessions, correspondence, minutes of camp boards and committees, as well as camp handbooks and manuals. Several files relate to the Synod of Toronto and Kingston Camp Board. Much of the work of the COM Programme was carried out directly through camp committees. Arrangement of records is by synod, with camps filed alphabetically under corresponding synod.

One of the main objectives of the COM programme was to carry out leadership development through regional workshops and consultations. These records document the organizing, planning and conducting of a number of leadership training events across Canada, addressing leadership within the camp committees by focussing on administrative skills, recruitment, selection, supervision and retention of staff.



**Records of the Church Education Programme. - 1973-1992. - 2 m. of textual records.**  
Committees of the BCL associated with Church Education Programme include the Advisory Committee on Family Life Education (1974-1979); the Advisory Committee on Youth Participation; the Advisory Committee on Church School Curriculum; the Committee on Worship and Life-Cycle Ministries (1979-1982); the Committee on Church Education (1979-1982); the Committee on Lay Ministries and Education (1982-1986); and the Church Education Committee (1986-1992). Staff responsible for church education include Helen Tetley, Brant Loper, Margaret Macnaughton, and Ian Clark. The staff person primarily responsible for church education was Helen Tetley.

Please note that from 1979-1982 there existed a Committee on Church Education which dealt with providing for the review, development, and evaluation of material resources, separate in representation and function from the Church Education Committee established in 1986.

Series consists of Leadership Development records, 1973-1990; records relating to Youth and Young Adult Ministry, 1976-1992; Resource Development records, 1974-1983; Interdenominational records, 1978-1992; Adult and Family Ministries records, 1974-1992; and records relating to Adult Education and Ministry with Men, 1976-1980.

The original order of the leadership development records, which consists primarily of correspondence with congregations regarding leadership training and selection and use of appropriate resources is arranged by presbytery. The mixed provenance of these records reflect the fact that leadership functions were distributed among various staff. Although the majority of these records originate from Helen Tetley, these files also contain correspondence to and from the following staff: David Murphy, Bert Young, Harry Waite, Wilma Welsh, Alex MacDonald, Don Powell, Wayne Smith, Hugh Davidson, and Albert E. Bailey. Several records dated 1973 originate from Albert Bailey, who was Senior Educational Consultant with the Board of Christian Education. The presbytery files contain information on workshops on eldership training, planning for local events, teachers learning skills, how to use curriculum materials, introducing CE:SA programme to presbyteries, correspondence with Congregational Life Committees, resources available from BCL, stewardship re: bulletins, requests for resources, and completed congregational activities forms for 1976/1977 and 1987.

Youth and Young Adult Ministry files contains reports and correspondence with the synod youth directors, as well as material on young adult observers to General Assembly and on Youth Triennium. These records also contain information on the Special Committee on Youth and Young Adults, in addition to correspondence and recommendations resulting from the survey titled Young Adult Participation in the Church. See also series on Evangelism Programs and Community Concerns for additional records on youth ministry.

A large part of the church education ministry focussed on curriculum distribution, development, and planning strategy. Resource development files include records on Bible Way Curriculum, Heritage Resources, Christian Education: Shared Approaches, and Joint Educational Development. As the last two titles indicate, curriculum development was often a collaborative, ecumenical effort. One exception to this was Heritage Resources, produced specifically for and by The Presbyterian Church in Canada.

Interdenominational records include a file on the Reformed Church in America that contains a 1990 field test report on the use of Bible Discovery and Celebrate resources.

Records relating to adult and family ministries includes material on Christian Education Sunday, ministry with singles and seniors, family ministries, and the Vanier Institute of the Family. Other adult education records are located with the subseries Adult Education and Ministry with Men. This set of files originates from Hamish Livingston, who was assigned responsibility for Specialized Ministries with Laity from 1976 to 1979, and Worship and Life-Cycle Ministries from 1979 to 1980. He assisted with leadership training by conducting workshops and conferences on marriage enrichment, and providing some administrative assistance to the National Committee of Presbyterian Men.

**Records of the Church and Society Programme. - 1984 - 1992. - 1.1 m. of textual records.**

The Church and Society programme related to the Committee on Church and Society, which existed from 1986 to 1992. Previous to 1986 the responsibilities for church and society were aligned with the portfolio of Evangelism Programs and Community Concerns. For more information, please consult the series description for Evangelism Programs and Community Concerns. After the Board of Congregational Life was dissolved in June of 1992 this program continued as Social Justice Ministries of the Life and Mission Agency. Records relating to the Consultation on Church and Society, for which the Programme Director of Church and Society served as Facilitator, have been removed from this fonds.

The responsibilities of the Programme Director for Church and Society included: providing resources for congregations, working closely with other ecumenical coalitions, maintaining an information base on social justice issues and making it available for congregations, and coordinating responses to social justice issues of the various constituencies for General Assembly. The Programme Director of Church and Society also served as a Field Education Supervisor for Knox students.

Series includes Correspondence, 1986-1992; Ecumenical Justice records, 1986-1991; Administrative records, 1986-1992; and records relating to Social Justice Issues, 1984-1992. Arrangement reflects original order of records, during 1991 the majority of records from this portfolio were maintained and used as a unit.

Correspondence records include government correspondence relating to decisions taken at General Assembly on such issues as aboriginal rights and the environment.

Ecumenical justice records include material on CACOM, the Coalition Administration Committee of the Commission on Justice and Peace of the Canadian Council of Churches. The Programme Director served as chairperson for this committee until 1989, as well as acting as the contact for the following organizations: ARC (Aboriginal Rights Coalition), CCJC (Church Council on Justice and Corrections), and TCCR (Task Force on Churches and Corporate Responsibility). Records on ecumenical justice coalitions dating from 1990 on are also located with the records on social justice issues.

Records relating to the Church and Society Committee can be found with administrative records. Correspondence regarding housing, the Presbyterian Social Justice Consultation, the farm crisis, human sexuality, and strategic planning are also part of administrative records.

Social justice issues formed the core of the church and society ministry. File titles reflect the various topical concerns that Canadian society faced in the late 1980's and early 1990's: aboriginal justice, environment, the Canadian constitution, global warming, the North American Free Trade Agreement, human sexuality, Canadian unity, and abortion.

**Records of the Evangelism Programme. - 1979-1991 (predominant 1986-1991). - 25 cm. of textual records.**

In 1986 the BCL structure was reorganized and an evangelism committee was formed. Prior to reorganization Evangelism was part of the programme known as Evangelism Programs and Community Concerns.

Series includes evangelism records, 1986-1991; and records relating to Cursillo, 1979-1992. Evangelism files consists of records originating from Alex McCombie, Programme Director for Evangelism from 1986 to September of 1989. After Dr. McCombie's departure, Ron Van Auken, Associate Director of Research and Church Growth provided leadership training by conducting workshops and presentations of follow-ups to the Evangelism Conference. The Executive Director, Ted Siverns, provided administrative support. In 1992 Ray Hodgson, Programme Director for Church and Society, also assumed temporary responsibility as Acting Programme Director for Evangelism.

Types of material include correspondence, reports, memos, lists and records on consultations and workshops. The records reflect the priorities of the Evangelism programme, mainly church growth liaison, synod consultants, evangelism conference, and the Schaeffer newsletter, "Developing Christian Community". Consult series description for Research and Church Growth for other material relating to consultations.

In 1979 the Task Force on Staff Functions recommended that Hamish Livingston, Associate Secretary for Lay Ministries and Education, develop a pilot project known as Cursillo. It became a programme of the BCL in 1980. The Presbyterian Cursillo movement, although an independent programme, was sponsored by the BCL and liaised with the Committee on Lay Ministries and Education. At the time the Cursillo Steering Committee reported to the Board as its sponsor, and Board representatives attended meetings of the Steering Committee. In 1989 this programme was placed under the leadership of the Committee on Evangelism. In 1991, staff person Wilma Welsh was assigned responsibility for this area, previously under the Programme Director for Evangelism. Records include correspondence, minutes, evaluations and questionnaires, guidelines, and lists of Cursillo participants. Minutes of the Steering Committee dated from 1980-1984 have been placed within the series Committees and Task Forces of the Board sousfonds. Minutes from 1985 to 1989 are missing. Minutes dating from 1990 to 1992 are with this series, as the Steering Committee was no longer under the sponsorship of the Board at this time.

**Records of Evangelism Programs and Community Concerns. - 1972-1985. - 1.2 m. of textual records.**

This programme had overall responsibility for work of the BCL in the areas of witness, outreach, and community action. From the inception of the Board of Congregational Life, evangelism and community issues were considered as two facets of the same program. When the structure of the BCL was reorganized in 1986 evangelism and social issues became two separate and distinct programs. A major function of this programme was the reviewing and developing of programmes and resources for evangelism, church growth, and community concerns for congregations and courts of the church, in addition to working with presbyteries and congregations to define local needs and issues relating to this ministry.

Staff responsible for this programme were Wayne Smith (1974-1977) and John Duncan (1978-1986). Some files contain records predating the formation of the Board of Congregational Life, as previous to 1974 the Wayne Smith was part of the Board of Evangelism and Social Actions, whose functions became part of the BCL, primarily exercised through Evangelism Programs and Community Concerns. One example of a programme which initiated with the Board of Evangelism and Social Action and continued under the BCL was the Evangelists-at-Large programme, where ministers conducted preaching and teaching missions, with congregations receiving assistance from the BCL.

Records relating to the Special Committee re Church in the World, the Committee to Double in the '80's, the Joint Task Force on Church Growth, the Committee on Church Growth, and the Consultation on Church and Society have been removed from the BCL fonds.

Series consists of records relating to Committees and Task Forces, 1974-1985; Correspondence, 1975-1984; Resource Development, 1975-1985; Ecumenical Organizations, 1972-1984; Social and Economic Issues, 1974-1985; and Evangelism and Church Growth, 1974-1980.

Committees responsible for policy aspects of this programme included the Advisory Committee on Evangelism Programs and Community Concerns (1974-1979); the Advisory Committee on Studies and Statements (1975-1978); the Committee on Studies and Statements (1979-1982); the Witness, Outreach and Community Action Committee (1979-1982); the Committee on Social Responsibility in Investment Policy (1978-1982); and the Committee on Outreach and Corporate Witness (1982-1986). Task forces which related to this programme include church growth, family law, human sexuality, marriage guidelines, and operation of the abortion law. Please note that when the Task Force on Marriage Guidelines was dissolved, it was replaced by the Task Force on Family Law.

Resource development consists of correspondence relating to the production of resources such as the Hangman's Kit, which dealt with the topic of capital punishment. Other resources were produced on subjects such as euthanasia and abortion.

Ecumenical organizations which related to this programme include various commissions of the Canadian Council of Churches and the Task Force on Churches and Corporate Responsibility. Files relating to Habitat are also found in this subseries.

Social and economic issues includes government correspondence, in addition to papers, reports, and statements issued by the Advisory Committee and the Committee on Studies and Statements. Files are arranged alphabetically by subject.

Evangelism and Church Growth files contain questionnaire responses with regard to the State of the Church Report, with presbyteries and congregations reporting to the BCL what actions were taken or planned in the area of church growth as a result of this report, which was adopted by the General Assembly in 1978. For related records see Committee on State of the Church fonds. Information on youth evangelism teams, the Evangelists-at-Large programme, and the ecumenical Christian Festival are also located within this group of files.

**Records of Research and Church Growth. - 1988-1990. - 37.5 cm. of textual records.**

In 1980 the General Assembly merged the Joint Task Force on Church Growth (BCL and BWM) with the Special Committee on Doubling in the 80's to form the Committee on Church Growth to Double in the 80's. This committee worked closely with the Board of Congregational Life through the Board's Committee on Outreach and Corporate Witness, which related to the portfolio of Evangelism Programs and Community Concerns. In 1988 the Committee on Church Growth was aligned with the BCL, and the mandate, objectives, and staff become part of the BCL from September of 1988 until December of 1990, when its mandate expired. Ron van Auken, executive staff for the Committee on Church Growth, assumed the position of Associate Director of Research and Church Growth within the Board of Congregational Life. Research and Church Growth presented its final report to the 1991 General Assembly. For further information, please consult the Church Growth report presented to the Board at its annual meeting in March of 1991, (file 1992-1261-4-11). For related material see also the records of the Joint Task Force on Church Growth, records of the Special Committee on Doubling in the '80's, and records of the Committee on Church Growth.

Series includes correspondence, 1988-1990; and records relating to consultations, 1987-1990. Consultation records are arranged according to congregation, and consists of the reports and the consultation background instrument, a specially designed questionnaire profile of the congregation.

**Records of the Stewardship Programme. - 1974-1986. - 37.5 cm. of textual records.**

The stewardship programme was associated with two committees of the BCL: Advisory Committee on Stewardship Education and Budget Promotion (1974-1979), and the Stewardship Committee (1980-1986). Staff associated with the stewardship were Alex Deans, Hugh Davidson, and David Murphy. As well, following David Murphy's departure the responsibilities for stewardship were shared between the Executive Director, who was responsible for the administration of the programme, the Programme Directors for Church Education and Worship, and the Administrative Assistant. In 1990 the Executive Director assumed stewardship as a part-time position.

The primary function of this programme was General Assembly budget promotion and stewardship and resource development. This included sponsorship of the Stewardship Conference. Sunday bulletins, initially part of the stewardship portfolio, became the responsibility of the Programme Director for Worship in 1986. In 1991 bulletins were transferred back to stewardship, with the work being contracted out.

Series consists of correspondence dealing with the General Assembly budget, allocations, resources, and comments on bulletin messages. Other records in this series are evaluations, reports, analyses, allocations, and budget summaries. Stewardship materials relating to workshops and seminars, and correspondence with stewardship presbytery convenors, form a large part of this series.

Please note that related records on stewardship can be found with the records of the office of the Executive Director, including material on Stewardship of Accumulated Resources. Records dealing with stewardship leadership development are located with the records on Church Education.

**Records of the Worship Programme. - 1974-1992. - 1.8 m. of textual records.**

Committees with responsibility for Worship include Worship and Life-Cycle Ministries, specifically the Task Force on Worship which reported to the above (1974-1982), and the Worship Committee (1982-1992). The staff person primarily responsible for the Worship programme throughout the existence of the Board of Congregational Life was Margaret MacNaughton.

In 1977 the BCL assumed the responsibilities of the Committee on Home Religion, mainly the work of the publication These Days. In 1978 the Committee on Church Worship, a General Assembly committee, became an advisory committee of the BCL. This committee subsequently amalgamated with the Committee on Family Life to become the Committee on Worship and Life Cycle Ministries. In March of 1982 the Board appointed a Committee on Worship, which became functional in January of 1983. The Committee on Worship was assigned the task of developing liturgical resources.

Records relating to Heritage Resources were part of the Church Education programme and are located with the Church Education series. Records relating to the Covenant of Grace Subcommittee of the Church Doctrine Committee, on which Margaret MacNaughton served as Convenor, have been removed from this fonds, as has the material on the Special Task Force on the Liberty of Conscience re Women.

Series includes records relating to Resource Development, 1983-1991; records of Ecumenical Organizations, 1983-1992; Leadership Development records, 1985-1991; Administrative records, and records relating to Liturgical Resources, primarily The Book of Common Worship, 1982-1991.

Leadership development consists primarily of records relating to Worship at General Assembly and the Worship Conference. Records include correspondence, hymns, sermons, notes, and minutes of the committees to plan worship at General Assembly and to plan worship event, respectively.

The Programme Director for Worship worked with other ecumenical organizations in developing worship resources, namely the Consultation on Common Texts (CCT), the National Council of Churches (NCC), the Canadian Liturgical Society, the North American Academy of Liturgy (NAAL), and participated in the Week of Prayer for Christian Unity. Records include minutes, correspondence, and material on liturgical texts.

Resource Development records consists of materials relating to the publication These Days, a devotional guide. Included in these files is correspondence relating to the Sunday bulletins, which had become the responsibility of the Worship programme in 1986.

A large part of the worship portfolio consisted of developing liturgical resources. The priority in this area for the years 1982 to 1991 was preparing The Book of Common Worship. Ten regional task forces were set up and worked closely with the Worship Committee and the Programme Director. Records include correspondence, notes, manuscripts, drafts, revisions, and support material. Records are arranged into three components: Word and Sacraments; Worship for the Way; and Orders for Courts. Also included in this subseries are records relating to the Task Force on the Psalter and the Task Force on Children at the Lord's Table.

Administrative records include Worship Committee files and correspondence, a file on the Worship and Liturgy Trust Fund, as well as other general files relating to the Worship programme.

**Publications of the Board of Congregational Life. - 1974-1992. - 1.4 m. of textual records.**

This is an artificial series within the Board of Congregational Life, as publications, resources, and newsletters scattered throughout the collection were grouped into one series. This series consists of resources and publications, including periodicals. Researchers should note that in addition to BCL generated publications, the scope of this series also contains curriculum resources that were used by the Presbyterian Church in Canada under the auspices of the Board of Congregational Life, but were not produced by the BCL. Examples of this type of publication include the newsletter "Developing Christian Community", as well as the Christian Education: Shared Resources curriculum.
