Sackville, New Brunswick St. Andrew's Presbyterian Church

Historical Sketch

The congregation of St. Andrew's Presbyterian Church in Sackville, New Brunswick dates from 1906. The congregation worshipped in a Church Hall until 1942 when the present Church was constructed. St. Andrew's was linked with St. James Presbyterian Church in Dorchester as a two-point charge at least by 1926, and with St. James Presbyterian Church in Port Elgin, as a three-point charge, from 1939 to 1968. In 1968, St. James Church in Dorchester closed its doors and the congregation amalgamated with St. Andrew's, Sackville. The link with Port Elgin was continued until 2001. St. James Presbyterian in Dorchester was established in 1880 by the Rev. Joseph Hogg of Moncton, N.B. The congregation initially worshipped in Robb Hall, but had built a church by 1885.

Saint John, New Brunswick The Presbyterian Church of St. John and St. Stephen

Historical Sketch

The Church of St. John and St. Stephen in Saint John, New Brunswick was formed in 1917 from the amalgamation of St. Stephen's Presbyterian Church and St. John's Presbyterian Church. St. Stephen's Presbyterian Church was established in 1836. Until 1847, the congregation worshipped in a building on Charlotte Street that was formerly a used by a Methodist congregation. This property was sold with the hope of a new church building, however it wasn't until 1868 that a new church was dedicated. St. John's Presbyterian Church was formed as a "Free Church" in 1843 by seceding members of St. Andrew's Presbyterian Church in Saint John. After leaving St. Andrew's, the members of the new St. John's Presbyterian Church purchased the Second Baptist Church at the corner of Carmarthen and Great George streets. For several years after the amalgamation in 1917, the congregation took the name Knox Presbyterian Church, however, there was a strong feeling for the old names and the title "The Church of St. John and St. Stephen" was adopted.

Salem, Ontario Salem Presbyterian Church

Historical Sketch

Salem Presbyterian Church began with the building of a frame church on the Tenth Concession of the Township of Elderslie (Bruce County). The first minister, Rev. George Bremner, served Salem from 1860 to 1870 and this was part of a two-point charge with Knox, Paisley, an arrangement which continued until 1874. From 1874 to 1877, Salem was linked with Chesley; from 1877 Salem was supplied by student ministers and others until in 1894, Salem was linked with Gillies' Hill. In 1900, Dobbington was added to Salem and Gillies' Hill to form a three-point charge continuing until 1925. That year Dobbington joined the United Church and Salem voted to remain within the Presbyterian Church. Salem and Gillies' Hill were then linked with Westminister, Paisley from 1925 until 1936, when the Gillies' Hill congregation was dissolved and Salem and Paisley continued as a two-point charge until 1956. In 1956 Salem was linked with Geneva, Chesley, and this arrangement continued until the Salem church closed in October 1969. In 1901, a manse was built on donated land opposite the church. The second church was built in 1922 on the site of the original building. Services were held in the manse while the new church was being constructed.

Salt Springs, Nova Scotia St. Luke's Presbyterian Church

Historical Sketch

St. Luke's Presbyterian Church, Salt Springs was organized along with Gairloch in 1822 as a congregation in connection with the Church of Scotland. In 1845, following the disruption some of the members of St. Luke's withdrew to form Ebenezer Church as a congregation of the Synod of Nova Scotia adhering to the Westminster Standards (Free Church Synod). In 1867 the two congregations of Salt Springs and Gairloch were erected as separate charges. Despite the union of 1875, St. Luke's remained a congregation of the Church of Scotland until 1896 when it petitioned the Presbytery of Pictou to be received as a congregation of the Presbyterian Church in Canada. The congregation was linked with the West River Mission Station in 1898. In 1908 Ebenezer was amalgamated with St. Luke's. In 1925 the congregation was split on the church union vote and there followed a property dispute which went to the Privy Council of the United Kingdom which finally awarded the property to the non-concurring Presbyterians. In 1933 St Luke's was linked with Durham and Salem (Green Hill) and this became known as the West River Pastoral Charge.

Sarnia, Ontario Laurel Lea - St. Mathew's Presbyterian Church

Historical Sketch

Laurel Lea-St. Mathew's Presbyterian Church in Sarnia, Ontario was formed by an amalgamation of Laurel Lea Presbyterian Church and St. Mathew's Presbyterian Church in June 1973. The Laurel Lea congregation was formed in 1949 out of a mission Sunday School begun by Paterson Memorial Presbyterian Church in 1946. The Sunday School was held at Meadowlea Public School. In addition to Sunday School, worship services were started in 1947. A church building was begun in 1949, and fully opened in 1955. St. Mathew's Presbyterian Church was established in March 1956, but was also formed out of a Sunday School mission begun in 1954 at the Queen Elizabeth II school. Worship services for the parents were begun in January 1956. Lots for a new church were purchased in the new development area, which was called "Coronation Park", in 1955 by St. Andrew's Presbyterian Church, Sarnia. Work on the construction of a church building was begun in August 1956, with the dedication being held on December 2nd. The cornerstone for a new church was laid in 1963. On June 1st, the two congregations of Laurel Lea and St. Mathew's were amalgamated under the name Laurel Lea – St. Mathew's Presbyterian Church.

Sarnia, Ontario St. Andrew's Presbyterian Church

Historical Sketch

St. Andrew's Presbyterian Church in Sarnia, Ontario was founded in 1841. In that year, the Presbyterian settlers in the area constructed a small brick church on part of the property on which the present church is located. The Rev. William Macalister was inducted into the charge on November 2, 1842. In addition to the new church in "Port Sarnia", he also served as minister to Plympton, and held services in a number of other villages in the district. After Rev. Macalister moved to Metis, Quebec, in 1853, the connection between the congregations in Sarnia and Plympton was dissolved. During the pastorate of Rev. John Thompson, which lasted from 1866 to 1903, a new church building was erected. The corner stone of the new church was laid on July 1st, 1867, and the building was dedicated on October 25th. The congregation voted to remain within The Presbyterian Church in Canada at the time of Church Union in 1925.

Sarnia, Ontario St. Giles Presbyterian Church

Historical Sketch

The congregation of St. Giles Presbyterian Church in Sarnia, Ontario was formally organized on September 20, 1946 as a mission station of The Presbyterian Church in Canada. The congregation started as a Sunday School which met in the home of Mr. Charles Cornish during the first half of 1944. By July of that year property had been purchased on Lake Shore Road where a tent was set up for both the Sunday School and a Vacation Bible School. A Mission Hall was constructed on the property during the latter half of 1944 and was opened in January 1945. Worship services in the new hall were begun on June 3rd of that year, and were conducted by student ministers. In 1949, the mission stations of St. Giles and Laurel Lea were linked as a two-point charge, with the Rev. Alex Campbell called as minister in May 1950. By 1952, the status of St. Giles had been elevated from a mission station to an augmented congregation. In 1954, the connection with Laurel Lea was discontinued and by 1956 St. Giles had become a self-sustaining congregation; no longer requiring financial assistance from the Board of Missions of The Presbyterian Church in Canada. Construction on a church building had begun in the summer of 1955 and the new church was opened and dedicated on November 24th, 1955. A Christian Education wing was added to the church in 1960

Sault Ste. Marie, Ontario Victoria Presbyterian Church

Historical Sketch

Victoria Presbyterian Church (Sault Ste. Marie, ON) was established in 1870 as a student summer mission. The town was formerly known as Korah West. Between 1865 and 1877 the student ministers were Mr. Damp, Mr. McEachren and Mr. Fear. The first minister to serve at Victoria was the Rev. J. R. McLeod who served from 1877-1878. In 1917 the Victoria Presbyterian church and the Methodist Church of North Prince were united and shared one minister. They changed their name at this time to The United Church of West Korah. In 1925 they voted to remain a Presbyterian congregation, at which time they changed their name back to Victoria Presbyterian Church. Since 1925, Victoria Presbyterian Church has been affiliated with St. Paul's Presbyterian Church (Sault Ste. Marie, ON).

In St. Paul's Presbyterian Church, services alternated between English and Gaelic, at first weekly, and then (by 1933) on a monthly basis until Gaelic services were dropped entirely in the mid-1950s. Over the years, St. Paul's Presbyterian Church grew, amalgamating surrounding Presbyterian congregations, notably St. Andrew's Presbyterian Church in Lake Megantic and Bethany Presbyterian Church in Milan in 1980.

Seaforth, Ontario Harpurhey Presbyterian Church

Historical Sketch

Harpurhey congregation was formed in 1835 to serve congregants in Tucksmith and McKillop. Their first minister was the Rev. Alexander MacKenzie (1835-1853), Harpurhey being part of a two-point charge with Goderich which continued from 1835 until 1846. In 1847 a frame church was erected to serve Harpurhey congregants. After that Harpurhey had its own minister until it amalgamated with Seaforth in 1879.

Seaforth, Ontario Seaforth Presbyterian Church

See First Presbyterian Church (Seaforth, Ont.)

Historical Sketch

In 1866 congregants in Seaforth attending Harpurhey or nearby Egmondville, sought to establish a congregation in Seaforth. This was approved by Huron Presbytery in 1867 on the condition that amalgamation with existing congregations nearby would be sought. Seaforth congregation began construction of a church on Goderich Street West (at Jarvis Street) in 1867 and called their first minister Rev. Thomas Goldsmith in 1870 who served until 1877. The first manse was a frame cottage on Goderich Street west of the church, then in 1879 the larger present brick manse was built just east of the first manse. In 1904, the church was remodeled, a gallery was installed and an addition built on the west side of the building. Seaforth amalgamated with Harpurhey in 1879 to form First Presbyterian Church, Seaforth.

Shakespeare, Ontario Shakespeare Presbyterian Church

Historical Sketch

Shakespeare Presbyterian Church (Ont.) was established in 1857 in the same year that the first church building was completed. The first minister was the Rev. Thomas Stephenson. The cornerstone of a new brick church was laid June 9, 1903. In 1925, Shakespeare Presbyterian Church voted to reject Church Union and continue with The Presbyterian Church in Canada. During the congregation's history, it was linked in a four point charge with Knox, North Easthope and Tavistock and later with: Knox, St. Andrew's and North Easthope.

Historical Sketch

St. Andrew's Presbyterian Church in Sherbrooke, Quebec was established in 1864. The Rev. Joseph Evans was inducted as the first minister to the congregation on October 28 of that year. Shortly after his arrival, the congregation purchased a theatre which had previously been a Congregational Church, and remodeled it to serve as their own church. This building was replaced with a newer structure in 1888. In 1925, the congregation voted to remain with The Presbyterian Church in Canada.

Simcoe, Ontario St. Paul's Presbyterian Church

Historical Sketch

The congregation of St. Paul's Presbyterian Church in Simcoe, Ontario was officially organized by the United Presbytery of Upper Canada in 1830. In that year, John Bryning, who had tended to the religious needs of the Presbyterian settlers in the area since c.1822, was ordained and inducted into the charge of Simcoe and Mount Pleasant. Prior to Bryning's arrival, Presbyterians in the Simcoe area were lead in worship by Rev. Jabez Collver, who served as minister from 1793-1818. The Disruption in Scotland in 1843 lead to the division of the congregation in 1846, with a majority of members desiring to remain connected with the Church of Scotland and a minority voting to join the Free Church. The majority formed the congregation which became St. Andrew's Presbyterian Church, while the minority formed what became the Norfolk Street Church. In 1876, these two congregations were re-united under the name St. Paul's Presbyterian Church. The congregation worshipped in the Norfolk Street Church until 1880 when it was sold. They then worshipped in the old St. Andrew's Church until construction on their new building was completed in 1886. At the time of Church Union in 1925, the congregation voted to remain Presbyterian.

A larger church was completed in 1863 and was know as the 'Big Church'. The Rev. John McNabb was the first minister to be inducted, his ministry began in 1867. In 1881, the Presbytery declared that the South Kinloss charge should be divided, thus there were two Presbyterian Churches in Lucknow. A new brick building was completed and dedicated on May 24, 1912. During the time of Church Union, South Kinloss chose to remain with The Presbyterian Church in Canada. South Kinsloss is currently part of a two point charge with Lucknow Presbyterian Church (Ont.).

South Mountain, Ontario St. Andrew's Presbyterian Church

Historical Sketch

St. Andrew's Presbyterian Church, South Mountain emerged as a charge in 1879 linked with South Gower under the ministry of the Rev. Archibald Henderson. From 1880 to 1881 St. Andrew's Mountain was added to these two congregations to make a three-point charge. In 1885 St. Andrew's South Mountain was linked with Heckston as a two-point charge, then from 1899 to 1921 St. Andrew's South Mountain was linked with both Heckston and Pleasant Valley as a three-point charge. In 1921 Heckston became a separate charge and South Mountain and Pleasant Valley continued as a two-point charge. In 1924 a Methodist congregation was associated with the charge and in 1925 Pleasant Valley went with the United Church of Canada. From 1926 to 1957 South Mountain and Knox, Mountain Station were linked until Mountain Station was closed. South Mountain then became linked with Knox, Iroquois and Dixon's Corners, Matilda in a three-point charge, which became a two-point charge in 1960 when Dixon's Corners, Matilda was closed. St. Andrew's South Mountain remained linked with Winchester until 1997 when St. Andrew's became a separate charge. In 1999 a three-point charge was formed with St. Paul's Winchester, Knox Mountain and St. Andrew's South Mountain; this continued to 1997 when the congregation of St. Andrew's South Mountain was dissolved.

Southampton, Ontario St. Andrew's Presbyterian Church

Historical Sketch

The congregation of St. Andrew's Presbyterian Church in Southampton, Ontario traces its origins to 1851, when the Rev. James Duncan arrived to the area and conducted services of worship for the Presbyterian settlers. Shortly after, the congregation was established as a mission station of the Presbyterian Church of Canada (the "Free Church"). A log church was built on lot 8, High Street in 1852. In 1860 another group of settlers formed a congregation within the United Presbyterian Church, and constructed a church on Clarendon Street. These two congregations amalgamated in 1862 and continued to worship out of the church on Clarendon Street until 1887, when the church was moved to its present site on Albert Street. At the time of Church Union in 1925, the congregation voted in favour of remaining with The Presbyterian Church in Canada.

Historical Sketch

St. Andrew's Presbyterian Church in St. Andrew's East, Quebec, was organized c.1818, when the Rev. Archibald Henderson was inducted as the first minister. For several years prior to this, however, Presbyterians in the area gathered together for worship under the leadership of the ministers from both St. Gabriel Street Church and St. Peter Street Church in Montreal. Shortly after Rev. Henderson's arrival work was begun on a church building. Land for the new church was donated by Sir John Johnston. Rev. Henderson served the congregation as minister and then minister emeritus until his death in 1877. The congregation voted to remain Presbyterian at the time of Church Union in 1925. In that same year a fire badly damaged the interior of the church.

St. Catharines, Ontario Knox Presbyterian Church

Historical Sketch

The congregation of Knox Presbyterian Church in St. Catharines was organized by the Rev. Thomas Christie, minister of the United Secession church in West Flamborough, on May 2nd, 1841. The first regular minister called to the new charge was the Rev. John Porteous, who was inducted on December 7th, 1842. Property was purchased on Centre St. and a small brick church was built by 1844. The congregation quickly outgrew this building and in 1860, the present structure was erected. At an annual meeting in 1875, the name Knox Presbyterian Church was chosen. Prior to this, it had simply been known as the Scotch Presbyterian Church. In 1925, the congregation voted to continue as a Presbyterian church rather than join with the United Church of Canada. A Christian Education Building was added to the church in 1956.

St. Catharines, Ontario Rockway Presbyterian Church

Historical Sketch

Rockway Presbyterian Church (St. Catharines, Ont.) was organized on October 9, 1809 by the Rev. Daniel Ward Eastman under the name First Louth Presbyterian Church. There was disruption in the services during the wars of 1812-1815. In 1824 the Presbyterian and Episcopalian congregations built a common building for worship called a Union Church. Louth was a united congregation with Pelham as early as 1841. This union remained and in 1900, North Pelham, Louth, and Fenwich became a three point charge. This continued until 1946 when Fenwich closed. Louth chose to remain with The Presbyterian Church in Canada during the time of Church Union in 1925. In 1955, Louth became a self sustaining congregation. In 1963, the name was changed to Rockway Presbyterian Church.

St. Catharines, Ontario St. Andrew's Presbyterian Church

Historical Sketch

St. Andrew's Presbyterian Church (St. Catharines, Ont.) was organized in 1875. The Presbyterians of Merritton felt that the trip to the church in Thorold was too far particularly for the children. In 1874, they petitioned the Presbytery to allow them to begin a Sabbath School and to conduct cottage prayer meetings. The Rev. S. C. Fraser came to supervise the meetings. In 1875, a church building was completed and the congregation became a mission station in connection with Thorold. The people applied to the Presbytery of Hamilton to be recognized as a congregation, this request was granted. The Rev. Fraser and Rev. George Bruce were appointed as commissioners to oversee the growth of the church. At some point, Merritton was absorbed by St. Catharines. St. Andrew's chose to remain a part of The Presbyterian Church in Canada during the time of Church Union in 1925.

Historical Sketch

First Presbyterian Church (St. David's, ON) was established in 1887. In November of that same year the congregation was linked in a united session with Haynes Ave. The first minister was the Rev. E. B. Chestnut, who served from 1889-1893. The united congregations were separated in 1897. The congregation of First Presbyterian Church rejected Church Union in 1925. In 1928, First Presbyterian became linked in a three point charge with Merriton and Port Robinson. In 1942, the congregation was united in a two point charge with the Stamford congregation. The congregation was united with Crowland, St. Catharines in 1957. By 1961, First Presbyterian was united with Scottlea of St. Catharines. This connection lasted until 1975 when First Presbyterian was again united with Crowland.

St. Elmo, Ontario Gordon Presbyterian Church

Historical Sketch

The congregation of Gordon Presbyterian Church in St. Elmo, Ontario traces its origins to c.1826 when the Presbyterian settlers in the area then known as the Indian Lands community began construction of a frame church in the 17th Concession. The first minister to conduct services in the church was the Rev. Archibald Connel, the minister in Martintown. In 1838, the Rev. Daniel Clark of Inverness, Scotland, arrived and served as missionary to the area for a year, before accepting a call as minister. In 1844, Rev. Clark and many of the families in the Indian Lands community broke away from the Presbyterian Church of Canada in Connection with the Church of Scotland and joined the Free Presbyterian Church. Disputes over ownership of the church and manse between the two groups continued until 1860 when it was given to the group in connection with the Church of Scotland. As a result the "Free Church" Presbyterians along with the minister, Rev. Daniel Gordon (who replaced Rev. Clark in 1853), began construction of a new church on the 19th Concession. This was opened in 1864. The name of this community at the 19th Concession became known as St. Elmo in the early 1880s, and the church became known as the "Gordon Church". At the time of Church Union in 1925, the congregation of the Gordon Church, St. Elmo, voted to remain with The Presbyterian Church in Canada.

St. John's, Newfoundland St. David's Presbyterian Church

Historical Sketch

The congregation of St. David's Presbyterian Church in St. John's, Newfoundland was formed in 1775 as a Congregationalist church. Services of worship were started under the leadership of Mr. John Jones, and by 1777 a meeting house had been constructed. This was replaced with a new building located on Duckworth Street which was completed in 1789. This second meeting house served the congregation until 1851, when construction on a Stone Chapel on Queen's Road was begun. During the Great Fire of St. John's in 1892, both the Stone Chapel and the second meeting house (which had become a Temperance Hall) were destroyed. The congregation decided to rebuild on the same site as the Stone Chapel and on September 16th, 1896, Queen's Road Congregational Church was opened. At the time of Church Union in 1925, the congregation remained a Congregationalist church. Due to the financial difficulty of securing a minister from the "Congregational Union of England and Wales", however, they were served by United Church ministers until 1932. In that year, The Rev. Joseph Thackeray, who had been minister to the congregation from 1897-1912, returned to serve as minister until his death in 1937. In 1938, at the congregation's request, it was received into The Presbyterian Church in Canada.

Historical Sketch

First Presbyterian Church, St. Marys was organized in 1848 with the Rev. John J. A. Proudfoot of the United Presbyterian Church of Canada as its first minister. The congregation was linked with Avonbank until 1856. A log cottage on Water Street North served as the manse and residence for the Rev. Proudfoot. The establishment of Chalmers Free Church in 1855 saw the transfer of members from First, St. Marys to that congregation but the two congregations united in 1861 with the union of the Presbyterian Church of Canada and the United Presbyterian Church of Canada to form the Canada Presbyterian Church. In 1878 the congregation was again divided on the authority of the Presbytery and a second congregation, Knox was formed. From its establishment the First congregation worshipped in the Cooper Shop, then the school in St Marys until a frame church was built on Widder Street in the 1850s/1860s. This structure was enlarged twice until in 1881, it was replaced with a new stone church building on the same property. In 1918, following the First World War, the two congregations of First and Knox were united as the St. Marys Presbyterian Church, but in 1921 this union was dissolved and the two congregations were restored, with First taking the name Widder Street Presbyterian Church, although later reverting to the name First. In 1925 First, St. Marys voted strongly in favour to remain within the Presbyterian Church in Canada. In 1952 there was a vacancy in Knox Presbyterian Church and in 1953 the two congregations agreed to share the minister of First Presbyterian church. Union of the two congregations took place in 1960, the united congregation taking the name of St. Marys Presbyterian Church.

Historical Sketch

Knox Presbyterian Church, St. Marys was established in 1878, when part of the congregation of First Presbyterian Church, St. Marys petitioned Stratford Presbytery to be allowed to form their own congregation. The first minister of the new congregation was Rev. W. A. Wilson who served until 1884. Knox congregation built their first church in 1879, however it was destroyed by fire in 1891. A second church was rebuilt that year within the wall of the first, but this was again destroyed by fire in 1905. While services were held in the Town Hall, the third new church was completed on the foundations of the old church and it opened that year. Knox was united with First in 1918, but when a petition was presented to Stratford Presbytery to dissolve the amalgamation, permission was granted to revert to the former status in 1921. In 1925 Knox voted to remain within The Presbyterian Church in Canada. A vacancy in Knox in 1952, prompted Knox and First Presbyterian Church to share the minister of First. The two congregations were united in 1960 taking the name St. Marys Presbyterian Church.

Knox Presbyterian Church in St. Thomas, Ontario was founded in 1837 and was originally known as St. Andrew's Presbyterian Church. The Rev. William McKillican was inducted as the first minister to the congregation. A church building on New Street was constructed in 1838. Originally connected with the Church of Scotland, the congregation voted to become part of the Free Church of Scotland in 1844. It was presumably at this time that the name was changed to Knox. In 1865 a new church was built on the corner of Mary and Talbot Streets. By 1883 the congregation had outgrown this building and a new church (the present structure) was erected. The congregation voted to remain Presbyterian at the time of Church Union in 1925. A Christian Education Building was added to the church in 1955.

In that year, however, they bought back the Cheyne Church building (constructed in 1918) from the United Church. An opening service was held on Christmas Day 1927, and the re-dedication on February 5, 1928.

Strathroy, Ontario St. Andrew's Presbyterian Church

Historical Sketch

St. Andrew's Presbyterian Church, Strathroy, Ontario was established as a congregation in 1863 when Communion was celebrated under the direction of Dugald S. McKellar at the Episcopal Methodist Church in Strathroy. The newly-formed congregation was connected with East and West Adelaide. In 1867 the first church building was constructed at the corner of Richmond and Albert Streets and the first Minister Rev. William Lundy was called that year, serving until 1872. The manse was built adjacent to the church in 1868 and a new church building (the present one) was constructed in 1878. Originally part of the Presbytery of London, St. Andrew's was placed within the Presbytery of Sarnia in 1880. In 1925, St. Andrew's voted overwhelmingly to remain within the Presbyterian Church. The manse was razed in 1942 and a new manse property was purchased on Oxford Street. In 1962, the Christian Education Building was added.

Sunbury, Ontario St Andrew's Presbyterian Church

Historical Sketch

St. Andrew's Presbyterian Church, Sunbury was established first as Storrington Presbyterian Church under the Canada Presbyterian Church (named for Storrington Township). It was linked with Pittsburg and Glenburnie from 1875. In 1904 its name was changed to Sunbury Presbyterian Church and from 1904 to 1925 it was variously linked with Glenburnie, Guthrie and Buck Lake as a mission field or a part of a pastoral charge. In 1925 Sunbury was linked with Bath in a twopoint charge, then from 1927 to 1930 Sunbury was linked with Pittsburg and Zion, Sandhill in a three-point charge. From 1931 to 1935 Sudbury was a student-supplied mission. In 1936 the name St. Andrew's Sunbury appeared for the first time in the Acts and Proceedings. Between 1936 and 1941 there were several re-alignments of congregations the area. In 1936, Deseronto, Camden East, Wilton, Glenvale and Sunbury were linked as one pastoral charge with Ernestown as a mission. In 1937 Deseronto and Sunbury were set up as a two-point charge and the other four were designated mission stations with student supply. In 1938 Deseronto, Camden East and Ernestown were linked as a three-point charge, while Sunbury, Glenvale and Wilton were linked as a three-point charge. In 1941 Sunbury, Glenvale and Wilton became student mission fields under Deseronto and in 1941 Wilton was closed. In 1943 Sunbury and Glenvale were placed with Deseronto and in 1944 Sunbury was separated from Deseronto and became a summer mission field. In 1987, St. Andrew's, Sunbury was dissolved.
