Board of Trustees and Trustee Board fonds. - 1900-1988. - 0.98 m of textual records.

The Board of Trustees was first appointed in 1898 in anticipation of the passing of an Act of Incorporation for The Presbyterian Church in Canada (Western Division) in each of the Provincial Legislatures outside the Maritimes. The process which led to this resulted from the death in 1896 of the Rev. William Reid, D.D., Agent of The Presbyterian Church in Canada (Western Division) when the Church discovered various legal complications arising from the property he held in trust for the Church and which the Church was unable to own as an unincorporated body. Accordingly, the Church appointed Dr. Robert Warden as the new Agent for the Western Division and the General Assembly of 1896 appointed a Committee on Legislation, with Warden as Convener, and instructed the Committee to work towards the formation of and Incorporated Board of Trustees. Initially the Board was envisaged as representing the entire Church but in 1899 the Synod of the Maritime Provinces stated that it was "not prepared to accept a General Board" (A. & P. 1899 Appendix p.310) and so the Committee was restricted to the Western Division of the Church. In 1900 legislation was passed in Quebec, Ontario, Manitoba and the North West Territories. and in 1901 in British Columbia. Following this, the Committee on Legislation was discharged. The Board of Trustees was appointed annually by Assembly and reported annually to Assembly until 1925. Similar Acts of Incorporation were obtained in the Maritime Provinces for other Boards.

At Church Union, the continuing Presbyterian Church in Canada appointed a Board of Trustees but the dispute over the correct name of the continuing denomination brought into question the legality of the Board. The United Church of Canada claimed to be the legitimate successor of The Presbyterian Church in Canada and the 1900 Acts of Incorporation were superceded by the United Church of Canada Acts. The new Board of Trustees was therefore authorized by the 1925 Assembly to look into the need for incorporation and the Trustees were in the meantime given responsibility for holding the assets of the Church as individuals. In 1931 the Trustees were authorized to transfer the assets they held to a Trust Company with an office in Toronto to administer on the Church's behalf (A. & P. 1931 p.71). In 1932 the question was again considered by the Assembly and while it was clear that it would be legally advantageous to incorporate the Board of Trustees, the Assembly agreed not to apply for any Acts of Incorporation: the principal difficulty perceived was the refusal of the courts to accept the title Presbyterian Church in Canada. Consequently, in 1934 the Board of Administration requested the General Assembly for authorization to have the power on behalf of the Church to deal with property, carry out legal proceedings, accept legacies and deal with other similar financial matters. In 1936 the Board of Administration was given authority to draft a Bill for the incorporation of the Trustees and a letter was received from the United Church of Canada which suggested the appointment of a committee to confer over matters of mutual interest. The Board of administration was able to report in 1938 that hostility to the use of the name, The Presbyterian Church in Canada, was breaking down and by 1939 it had been agreed to alter the United Church of Canada Act to remove the legal barriers in the United Church Acts. As a result, an Act to incorporate The Trustee Board of The Presbyterian Church in Canada was passed in the Federal Parliament in April 1939.

The Act to incorporate The Trustee Board of The Presbyterian Church in Canada was passed April 5, 1939 creating "a trustee board to acquire, take, hold and deal with real and personal property." The Board was to consist of not less than seven and not more than fifteen with membership including the Chairman of the Administrative Council and the Treasurer. The Board was to have a common seal to use for all business transactions. The Board was entitled to purchase, lease, acquire, take, hold, receive, and enjoy, all or any property in fullest manner allowed by the law. It was given the power to invest, reinvest and lend money upon any of the securities it purchased and maintained. The Board was given tools to enforce repayment with that the power to endorse and execute bills of exchange, promissory notes and orders of payment.. The Board was given the power to receive and hold trusts in connection with the Church and retain property as an investment providing that money made was reinvested into the property or proper funds. The Trustee Board was to play a role in establishing pension plans and ensuring other annuities were delivered upon. The Trustee Board was given the ability to consolidate investments provided that the consolidation did not infringe upon the regulations placed upon the investment. The Trustee Board was to report annually to the General Assembly and set forth fully the moneys, securities and property which hand come into the hands of the Board in the preceding year along with the moneys, securities and property still being held and the income being generated by those sources.

Fonds consists of legislation concerning the incorporation of the Board of Trustees and Trustee Board, minutes, correspondence, agenda items, will and bequest information, and financial ledgers and material. The are also minutes and financial ledgers for the Investment Advisory Committee. The David Chestle Soules Company ledger is also included in this fonds.

Title taken from the content of the fonds and the evolution of the Board.

Fonds consists of two accessions, one coming in 1973, the second coming in as part of a large transfer of records for the Comptroller's Office in 1989. The first accession was re-catalogued in 1988 by Elspeth Reid. Additional processing and a preliminary RAD description were added by Cheryl Saunders in 1997.

This finding aid is listed as FA-TRUST.

Due to the activities of the Trustee Board, particularly regarding its execution of documents under seal, related documents the Trustee Board was involved in can be found under the Properties Discharged and Sold in the Church and Manse fonds finding aid, FA-MANSE.

Series descriptions

Investment Advisory Committee. - 1965-1987. - 27 cm of textual records.

The Investment Advisory Committee was created as a standing committee of the Trustee Board. The committee was established to make recommendations to the Board of Trustees concerning its general investment policy, provide constant supervision of the portfolio and to review regularly the Church's investments for the purpose of maintaining or improving the quality of the investments and income derived from them. The Committee also reviewed quarterly reports and statements received by the Board of Trustees relating to their investments and report their findings to the Board. The Committee, within the approved policy, arranged sales, purchases or exchanges of investments in the best interests of the Church. All transactions were recorded and reported by the secretary of the Committee. A report was submitted to the annual meeting of the Trustee Board.

Series consists of minutes, agenda items, correspondence and cash books related to the operation of the Committee.

D.C. Soules Company. - 1968-1984. - 2 cm of textual records.

Reverend David Chestle Soules died on December 12, 1968 leaving to the Church the residue of his estate valued at slightly less than one million dollars. The funds were left in the care of his Executors and Trustees, the Secretary of the Administrative Council and the Secretary of the Trustee Board. Due to the constant changes which occurred in these positions, the incumbents advised the Court they did not wish to continue their duties in this capacity and that the Court name the Trustee Board as the sole Executor and Trustee of the Estate. The Trustee assumed control of the portfolio and discontinued the practice of providing an audited statement because no public accounting was required. The Company was maintained until the tax implications were dealt with and then absorbed in the dealings of the Trustee Board.

Series consists of a single ledger documenting the investments of the Company.
