### **Committee on Recruitment and Vocation**

#### **Historical Sketch**

The Committee on Recruitment for Full-Time Service was authorized by the 1944 General Assembly on the recommendation of the General Board of Missions. The initiative for the Committee came from a conference called by the Board of the Missionary and Deaconess Training School to which representatives of the W.M.S. (W.D.) and the General Board of Missions were invited. The conference considered "the question of future leadership in our Church in the post-war era" (Acts and Proceedings 1945, appendix p.299). In 1965 the committee was renamed the Committee on Recruitment and Vocation and its composition was altered. The committee was discharged in 1970 at its own recommendation: the committee cited its reasons the imminent re-structuring of the Boards and Committees of the Church along with the prospect of increased work with no staff to do the work. The major project of the Committee on Recruitment and Vocation was a research and development project which was authorized by the 1968 General Assembly. The Committee hired the management consultants, P.S. Ross & Partners, to conduct a survey on ministry in the Church. The Ross Report, as the resulting report was known, was published in October 1969 and formed the research part of the project. The development aspect was felt to by the Committee to be too large a task to complete without full-time staff. Concurrent with this report was the Report on the State of the Church and its successor, the LAMP Report (Committee on Life and Mission). All three reports contributed to the REstructuring of the administration of the Church during the 1970s.
