Introduction

This collection contains three separate accessions of records of the Board of Administration, its officers and committees, totalling approximately three metres.

The records were re-catalogued and listed by Kim Arnold and Elspeth Reid in October and December 1988.

The finding aid is listed as FA-BDADM.

Historical Sketch

The Board of Administration was set up in 1925 following the formation of the United Church of Canada and the consequent disruption and re-organization of the Presbyterian Church in Canada. It had its roots in the Provisional Standing Committee on Organization of the Presbyterian Church Association which was formed in August 1924 in anticipation of the 1925 re-organization. The Board of Administration under the terms agreed by the 1925 General Assembly was composed of

"laymen experienced in business and finance, whose duty it shall be to take the oversight of all the business and financial affairs of the Church, including the investment of all funds of the Church (1)

The first Secretary of the Board of Administration was the Rev. J.W. MacNamara, one of the Joint Clerks of Assembly and formerly the Secretary of the Presbyterian Church Association. He held the post of Secretary until 1946. On his retirement, he was replaced as Secretary by the Rev. E.A. Thomson, also a Clerk of Assembly, who held the post until the Board of Administration was dissolved in 1960 and replaced by the Administrative Council.

The Board of Administration established a number of Committees with responsibility for various aspects of the work of the Board. In addition funding campaigns were placed under the Board of Administration by the General Assembly. The Board was primarily responsible for the finances of the Church and for recommending the financial allocations to all the other Boards and Committees of the Church.

The Presbyterian Advance for Christ and Peace Thankoffering

The Presbyterian Advance for Christ and Peace Thankoffering was authorized by the General Assembly of 1945 on the recommendation of the Board of Administration. This was a fund-raising campaign, initiated by the Anglican Church and carried out by the Anglican, United, Baptist and Presbyterian Churches as a means of financing reconstruction in Canada and overseas following the end of the Second World War. The Presbyterian campaign was to raise \$2,000,000 but by the end of the campaign in 1949 approximately \$1,500,000 had been contributed. The final report in the Acts & proceedings of 1949 noted that the fund-raising was not the only purpose or achievement of the campaign:

In many congregations and some presbyteries the Advance led to the discovery of potential lay leadership which gained experience and knowledge of the church and will now take part in its continuing work. Experiments were made in organization and much valuable experience was gained for the church at large, as well as in presbyteries and congregations. But perhaps the greatest gain lay in the fact that the church became more and more aware of its responsibility for the future, for wise and vigorous plans and for a strong sense of purpose under the guidance of the Holy Spirit.

Committee on Chaplaincy Service

The Committee on Chaplaincy Service was appointed by the Board of Administration in September 1940 *"to co-operate with the Department of National Defence, Ottawa, in the appointment of Chaplains for Service Overseas and in the Dominion"* (A. & P. 1940 Appendix p.164). The committee also acted as a means of pastoral care for the Chaplains and their families, working in co-operation with similar committees of other Churches. An Inter-Church Chaplaincy Committee was set up during the war and the Chaplaincy Service Committee sent representatives to that committee. The Committee reported directly to General Assembly annually. In 1965 the name was changed to the Armed Forces Chaplaincy Services Committee to distinguish it from the Committee on Institutional Chaplaincies and in 1970 it became the Canadian Forces Chaplaincy Committee. In 1977 it was associated with the Board of Ministry and in 1978 it became a Committee of the Board of Ministry with the right to continue to report separately to General assembly. This position was to be reviewed in 1983 but was actually reviewed in 1986 and the relationship with the Board of Ministry was continued.

Archival Arrangement

This collection consists of approximately three metres of the records of the Board of Administration, 1925-1959, (mainly 1925-1947) and of the Chaplaincy Service Committee, 1939-1957, and the Presbyterian Advance for Christ and Peace Thankoffering, 1945-1953.

Accession #1973-1007 consists of approximately 1.8 metres of the records of the Secretary of the Board of Administration, the Rev. J.W. MacNamara. Most of these records consist of the correspondence of the Secretary and collected copies of legal documents relating to the settlements between the United Church of Canada and the Presbyterian Church in Canada over disputed church property and the division of the various benevolent funds of the Presbyterian Church. They include some of the judgements of the Provincial and Dominion Church Property Commissions and copies of the documents presented to the Commissions in support of the arguments of the two Churches. There is also correspondence with lawyers representing the two Churches. The records relating to the Provincial and Dominion Church property Commissions have been retained substantially in the order in which they were held in the Archives until re-cataloguing. The records relating to congregational church property settlements have been grouped into a file series and arranged by province. Similarly the records relating to the benevolent funds have been grouped into a file series. In addition to these records there are also records of the legal firm, McCarthy and McCarthy, which represented the Presbyterian Church in Canada at the Church Property Commissions and in many individual congregational property cases. The records of this firm relating to the church property settlements were deposited with the Board of Administration at some point.

As well as the records of the church property settlements, accession #1973-1007 also contains some other correspondence files of the Secretary, mainly relating to issues arising from the 1925 union and other routine business. A separate file series of correspondence, pamphlets and other records relating to the work of the Secretary with committees of the Board of Administration is listed at the end of this accession.

Accession #1973-1004 consists of 1 metre of correspondence of the Secretary of the Presbyterian Advance for Christ and Peace Thankoffering, the Rev. Wilfred F. Butcher. These records were originally filed in alphabetical order by file title and this order has been retained. It should be noted that this means that correspondence with individuals, in alphabetical order by surname, is interspersed with correspondence with Presbyteries, Boards of the Church and Committees, along with the occasional subject file.

Accession #1973-1006 consists of the records of the Chaplaincy Services Committee for the period 1939 - 1957. The minutes are listed first, then correspondence in chronological order, followed by a pamphlet published by the Committee.
