St. Andrew's Presbyterian Church

Historical Sketch

St. Andrew's Presbyterian Church, Darlington was organized in 1842 with the assistance from the Colonial Committee of the Church of Scotland. In 1844, five of the nine Trustees entered the Presbyterian Church of Canada whereupon ownership of the church building was disputed. In 1845 the Court of the Queen's Bench awarded the building to the congregation in connection with the Church of Scotland. Thereafter the congregation met in a church in Bowmanville, Ontario. After a vacancy of some years, St. Andrew's Darlington appears to have been closed c.1889.

Knox Presbyterian Church

Historical Sketch

Knox Presbyterian Church started as a mission station in the mid-1880s. At a meeting on January 12, 1903, it was decided to build a church which was opened on June 3, 1906. Rev. John Graham was the first ordained minister to preach at Knox. The congregation was included in the Oil Springs, St. John's charge until 1933 when it joined with the Brigden-Bear Creek charge. In 1973, Knox and Brigden joined the Point Edward charge. The congregation was dissolved in 2018.

Historical Sketch

The Hungarian Presbyterian Church started as a mission field in March 1948 under the pastoral charge of the Hungarian Congregation of Brantford. It became a self-sustaining congregation c. 1957 and took the name Calvin Presbyterian Church in 1966. From 1997 until 2000, it was part of a two-point charge with Pleasant Ridge in Brantford, which dissolved in 2000. The congregation dissolved in December 2017. It was a Hungarian-speaking congregation and many of the records are written in Hungarian.

Historical Sketch

Demorestville Presbyterian Church – later known as Knox Presbyterian Church – was organized in 1830 as part of the Presbyterian Church of Canada in connection with the Church of Scotland. Its first minister was Rev. Robert McDowell. There is mention of the Rev. James Rogers serving the Demorestville congregation as well as St. Andrew's Picton and Hillier, before being officially inducted as minister of Demorestville in 1838.

Land for the church was donated in 1830 by Mr. Demorest, founder of the village, and the building was completed in 1832. Following the Disruption of the Church of Scotland in 1843, Rev. Rogers and the congregation joined the Free Church of the Presbyterian Church of Canada in 1844. In the years that followed, services were infrequent, several ministers came and went, and by the time the congregation dissolved, the church was largely supplied by student ministers. In 1909, the original church was demolished and replaced with a new building on the same site.

Records from Knox also mention a congregation known as Union Church (or Black's Church), located on Back Road in Demorestville. Minutes from 1841 document a meeting of Union's elders and trustees, and in 1887, Union was represented at a Knox congregational meeting to engage an ordained missionary to serve both congregations. Union and Knox appear to have shared a Session, jointly contributing to ministerial stipends while raising funds separately to maintain their buildings.

In 1925 the congregation voted to remain within The Presbyterian Church in Canada, but later that year, closed due to financial hardship. In December 1929, the congregation petitioned the Presbytery for dissolution, which was formally granted on March 5, 1929.

Dorchester, New Brunswick
St. James Presbyterian Church

See St. Andrew's Presbyterian Church (Sackville, N.B.)

Historical Sketch

St. James Presbyterian in Dorchester was established in 1880 by the Rev. Joseph Hogg of Moncton, N.B. The congregation initially worshipped Robb Hall but had built a church by 1885. By 1926, they were linked with St. Andrew's Presbyterian Church in Sackville as a two-point charge, and in 1939, with St. James, Port Elgin, as a three-point charge. In 1968, the church closed its doors and amalgamated with St. Andrew's in Sackville.

Dorchester, Ontario

Dorchester Presbyterian Church

Historical Sketch

Prior to 1854, a group of Presbyterians in Dorchester worshipped in the local Anglican church. That year, the Presbytery of London formally organized the congregation in Dorchester. Rev. John Scott of St. Andrew's Presbyterian Church in London, Ontario, assisted with planning and fundraising for the construction of a church building. A simple wooden structure was completed in 1855.

In 1877, Dorchester Presbyterian Church merged with Crumlin Presbyterian Church, and a larger church building was constructed in 1889. A selection of items was placed in the cornerstone, which was opened in 1989 to mark the building's 100th anniversary.

Initially, the congregation voted in favour of Church Union, but a second vote was held, with the majority opposing the union. The church was closed for a time but reopened in 1928. At this time, Dorchester became a two-point charge with St. George's in East London. This arrangement continued until 1958, when St. George's became self-sustaining. Dorchester then formed a two-point charge with South Nissouri Presbyterian Church, a relationship that lasted until 2020. Dorchester Presbyterian Church dissolved in January 2024.

Historical Sketch

St. Andrew's Presbyterian Church, Dresden began in 1872 as a Mission Station under the charge of Mr. G.G. McRobbie, a student minister and Gilbert Tweedie, M.D. a medical doctor and lay preacher. In 1876 the congregation erected a church building in North Dresden. In 1879 the Dresden church was united with Knox, Chatham Township as a two-point charge. The first ordained minister was the Rev. Thomas Tallach, inducted in 1881 who served until his death in 1890. In the winter of 1895 several years of planning culminated with the church building being moved across the river ice to a new location "next to the Fire Hall" in Dresden. In 1925 the congregation voted unanimously to remain with the Presbyterian Church in Canada. The church hall was completed in 1927. The congregation changed its name from Knox to St. Andrew's in 1963.

Amos Presbyterian Church in Dromore, Ontario was founded in the mid-1800s. A church building was constructed in 1864 on property donated by Mr. and Mrs. George and Margaret Amos. The first minister called to the church was the Rev. H. Crozier. Prior to 1878 the congregation was linked with the congregations in Fairbairn and Holstein as a three-point charge. After 1878 it was linked with Knox Presbyterian Church, Normanby in a two-point charge. In 1962, the two congregations were once again linked with Holstein in a three-point charge. The original church was replaced with a brick building in 1884.

Dunblane Presbyterian Church in Ontario was founded in 1859 by settlers along the Saugeen River. The original congregation belonged to the Free Church before joining the United Presbyterian Church in 1860. Throughout the years the congregation had relations with the Paisley Congregation, Southampton, Port Elgin, and Burgoyne. The original building was made from logs taken from the banks of the Saugeen River, which has since been covered in lumber and plaster. The congregation was dissolved in 1968, but a committee of volunteers continued to protect the heritage site. A special annual service continues to be held in the building.

Historical Sketch

The congregation at Dundalk and Fraser Settlement was established in 1878 under the leadership of Rev. John Morrison. By the end of that year, a session had been organized, a new building was opened, and a student named Mr. Henry had assumed leadership. In 1880, the congregation applied to the Presbytery for the services of an ordained minister, and Rev. J.S. Eakin took the position. Beginning in 1888, the Dundalk and Ventry (former Fraser Settlement) congregations appear in the Acts & Proceedings as a two-point charge. Eventually, the congregations adopted the names Erskine (Dundalk) and Knox (Ventry). In 1958, these two congregations became part of a three-point charge, which also included St. Andrew's in Maple Valley. Then, in 1967, Erskine and Knox amalgamated, joining the Markdale charge, which included Cooke's P.C., Markdale; Burns P.C., Feversham; and St. Andrew's P.C., Swinton Park. This charge was subsequently divided in 1975, with Erskine and Swinton Park forming their own two-point charge. Erskine Presbyterian Church dissolved in June 2019, while Swinton Park remains active.

Notes

This congregation has a somewhat complicated structural history. The original congregation of Dundalk and Fraser Settlement split into two congregations which remained part of the same charge. The minister appears to have used the same registers for both congregations but has not necessarily indicated which congregation each entry relates to. Thus, the vital statistics for the congregations at Dundalk and Fraser Settlement/Ventry are mixed.

Historical Sketch

Knox Presbyterian Church, Dundas, was formed in 1844 by the division of the St. Andrew's Presbyterian Church, Dundas, as a result of the Disruption of the Church of Scotland and the formation of the Presbyterian Church of Canada. Its first minister was the Rev. Mark Young Stark who was also the first Moderator of the Presbyterian Church of Canada. Knox was linked with the congregation at Ancaster until 1854. In the 1870s, with the union of the various Presbyterian churches, Knox and St. Andrew's were also re-united and the enlarged congregation retained the name of Knox. The congregation sold their church building in 2022 and continued to hold worship services out of St. Mark's United Church.

Historical Sketch

Knox Presbyterian Church in Dunnville, Ontario, traces its origins to 1833, when the Presbyterians in the area began to meet for worship. In 1834, they were organized under the Niagara Presbytery of the American Presbyterian Church. By 1835, however, the congregation had joined the Presbytery of Hamilton within the Presbyterian Church in Canada. In 1845, property at Lot 19 on the north side of Lock Street was purchased and a church building was constructed soon after. This building was replaced in 1906/07, and the new church was formally dedicated on September 27, 1907. The congregation voted to remain within The Presbyterian Church in Canada at the time of Church Union in 1925.

Historical Sketch

The congregation of Kenyon Presbyterian Church in Dunvegan, Ontario dates from 1838, when The Rev. Daniel Clark was appointed as minister to the area. In 1840, a log church was constructed by the congregation. After Clark's retirement in 1849, the pulpit was vacant until 1853, when The Rev. Daniel Gordon arrived. Kenyon Church was joined with the congregations in Indian Lands and Roxboro from 1853 to 1856, when Kenyon was separated and established as a distinct charge. As the congregation grew, it was decided to build a larger church. Construction was begun in 1872, but the formal opening wasn't until September 9, 1880. At the time of Church Union in 1925, the congregation voted to remain within The Presbyterian Church in Canada.

Durham Presbyterian Church was formed in 1925 when most of the congregation of Knox Presbyterian Church (Durham, ON) entered the United Church of Canada. The minority (45%) formed Durham Presbyterian Church, calling the Rev. B.D. Armstrong in 1925. They completed new brick church in 1927 having bought all the contents from Guthrie Presbyterian Church in Harriston. The church was refurbished in 1957 and in 1974 a two-story addition for Sunday school and the church office was completed.
